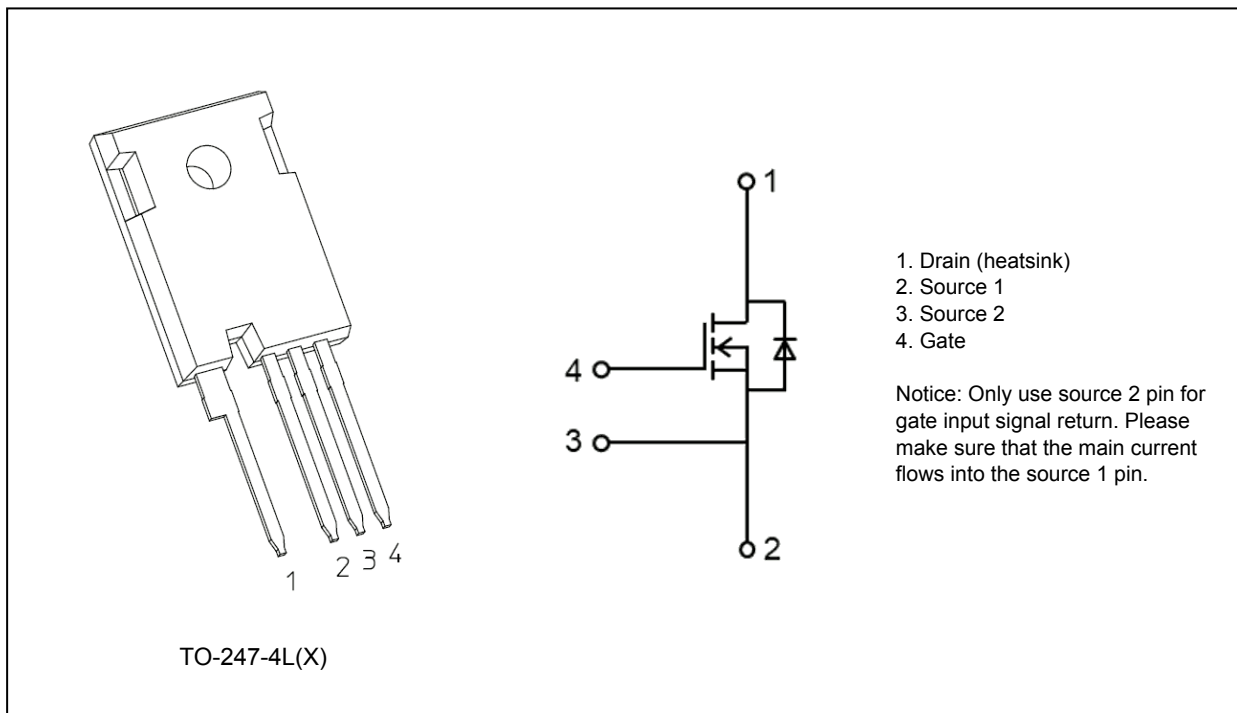

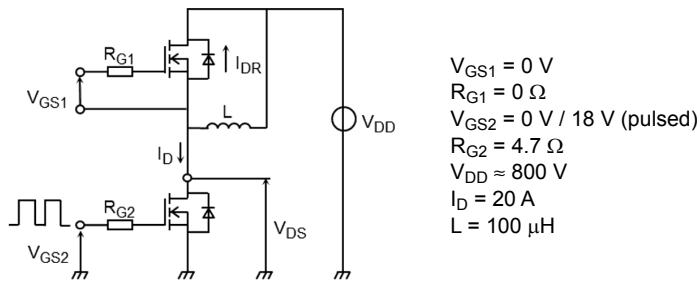


Fig. 6.2.1 Switching Time Test Circuit

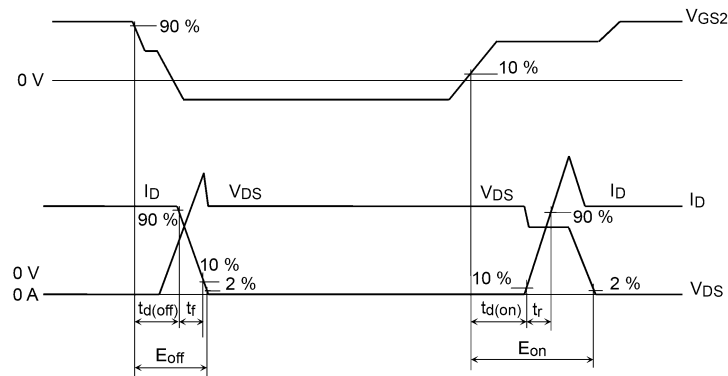


Fig. 6.2.2 Timing Diagrams

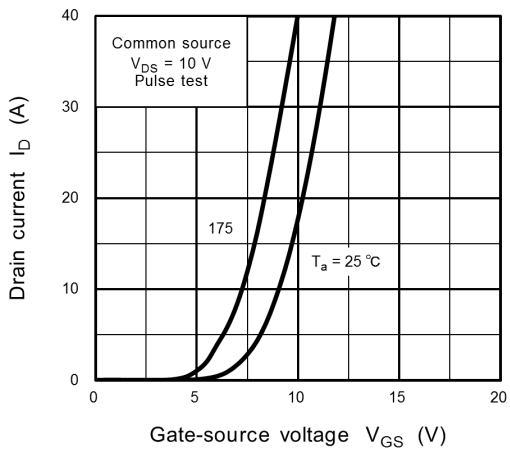

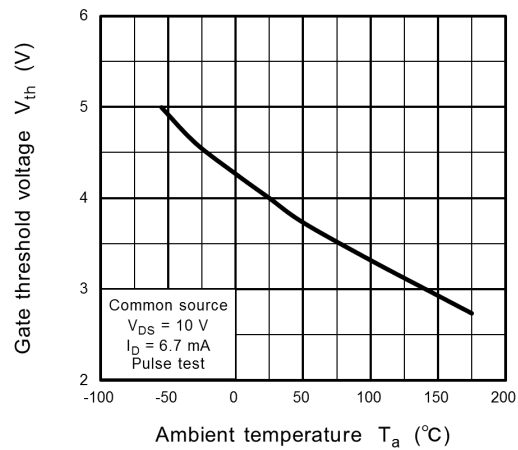
**Fig. 8.1  $I_D - V_{DS}$**



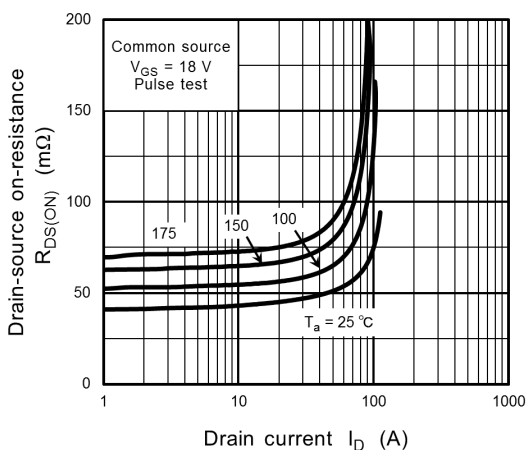
**Fig. 8.2  $I_D - V_{DS}$**



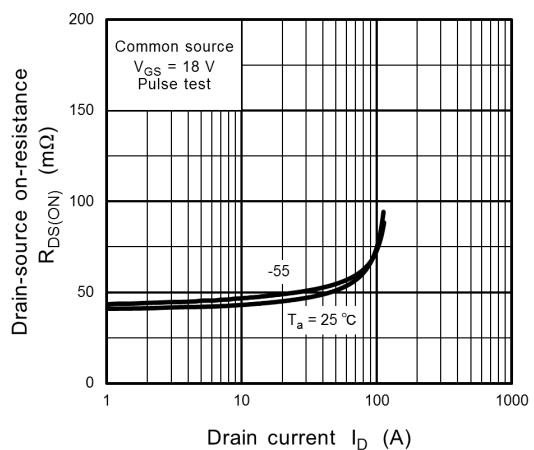
**Fig. 8.3  $I_D - V_{GS}$**

**Fig. 8.6  $R_{DS(ON)} - I_D$**

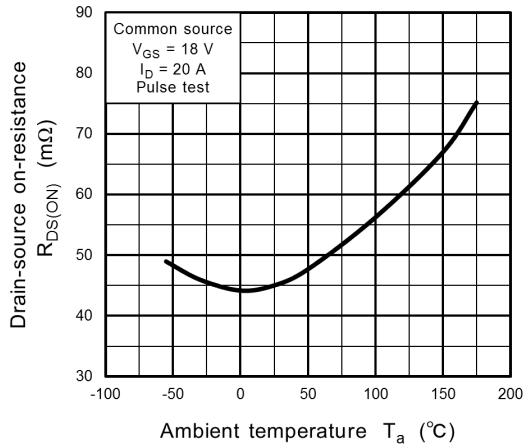


Fig. 8.7  $R_{DS(ON)} - T_a$

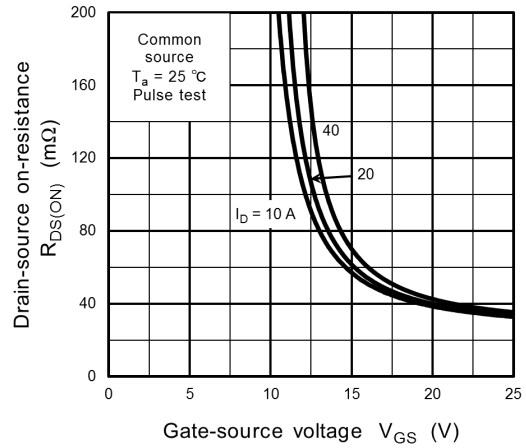


Fig. 8.8  $R_{DS(ON)} - V_{GS}$

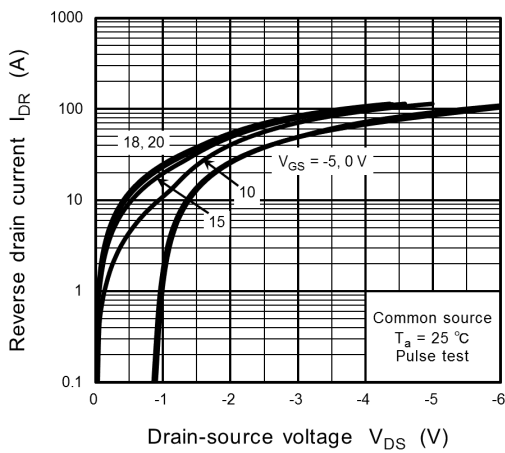


Fig. 8.9  $I_{DR} - V_{DS}$

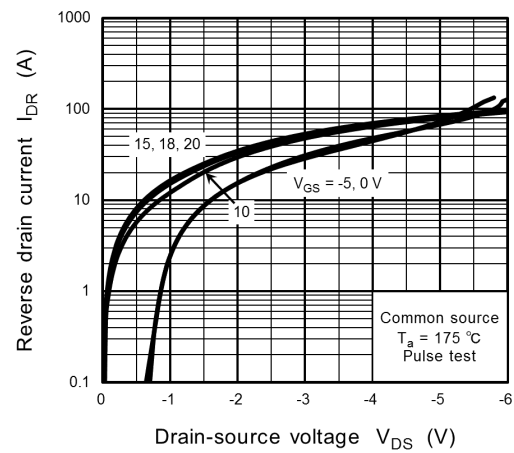


Fig. 8.10  $I_{DR} - V_{DS}$

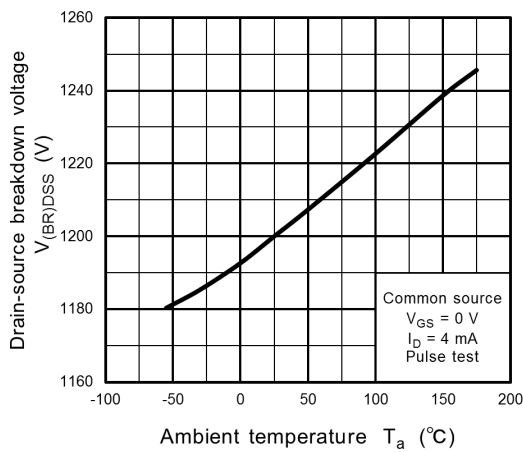


Fig. 8.11  $V_{(BR)DSS} - T_a$

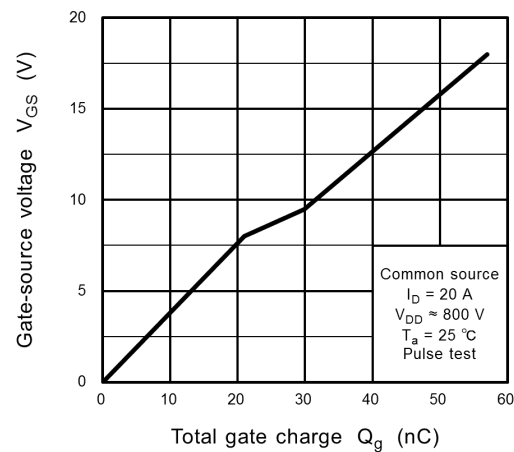
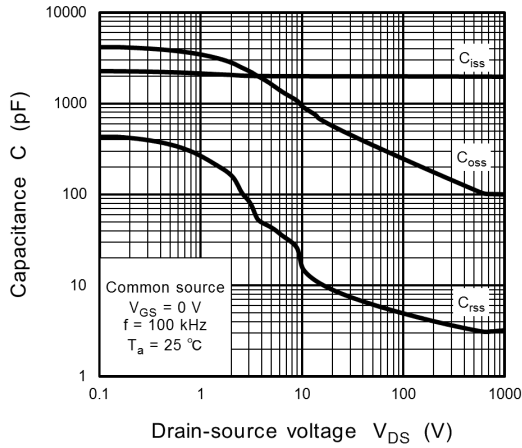
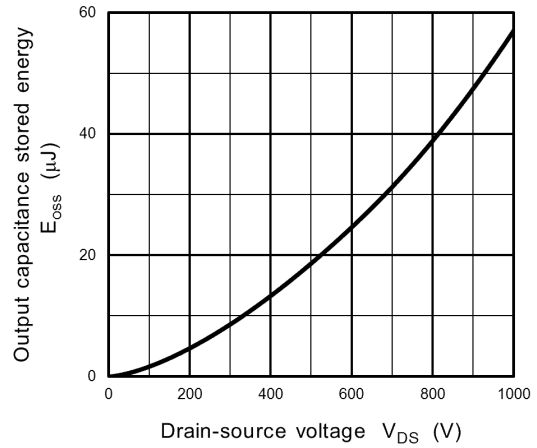


Fig. 8.12 Dynamic Input Characteristics

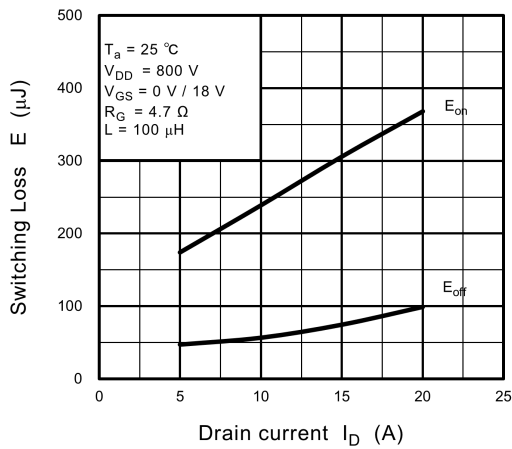




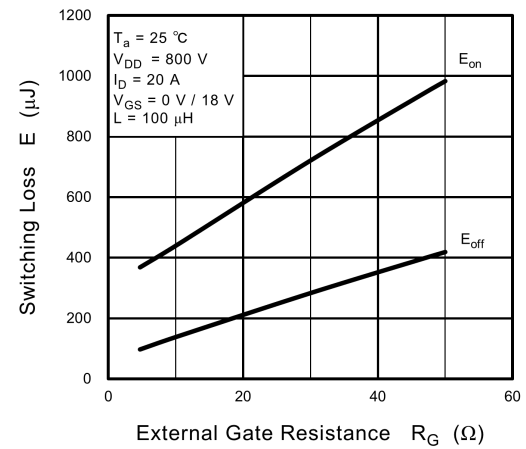
**Fig. 8.13 C -  $V_{DS}$**



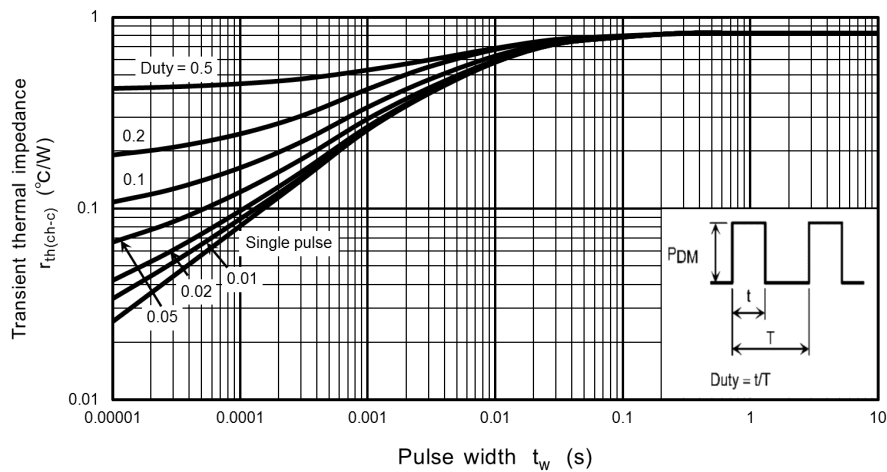
**Fig. 8.14  $E_{oss}$  -  $V_{DS}$**



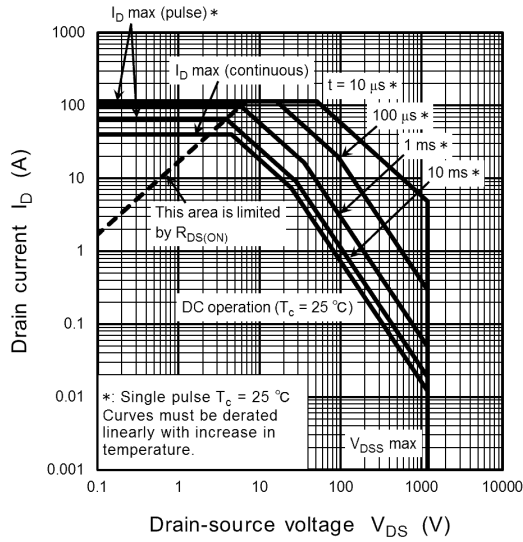
**Fig. 8.15 E -  $I_D$**



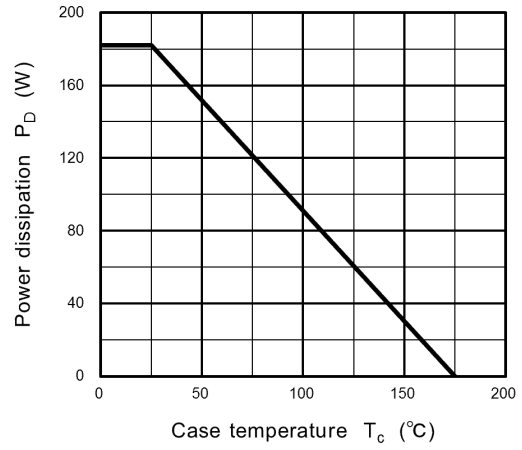
**Fig. 8.16 E -  $R_G$**

**Fig. 8.18 Safe Operating Area (Guaranteed Maximum)**

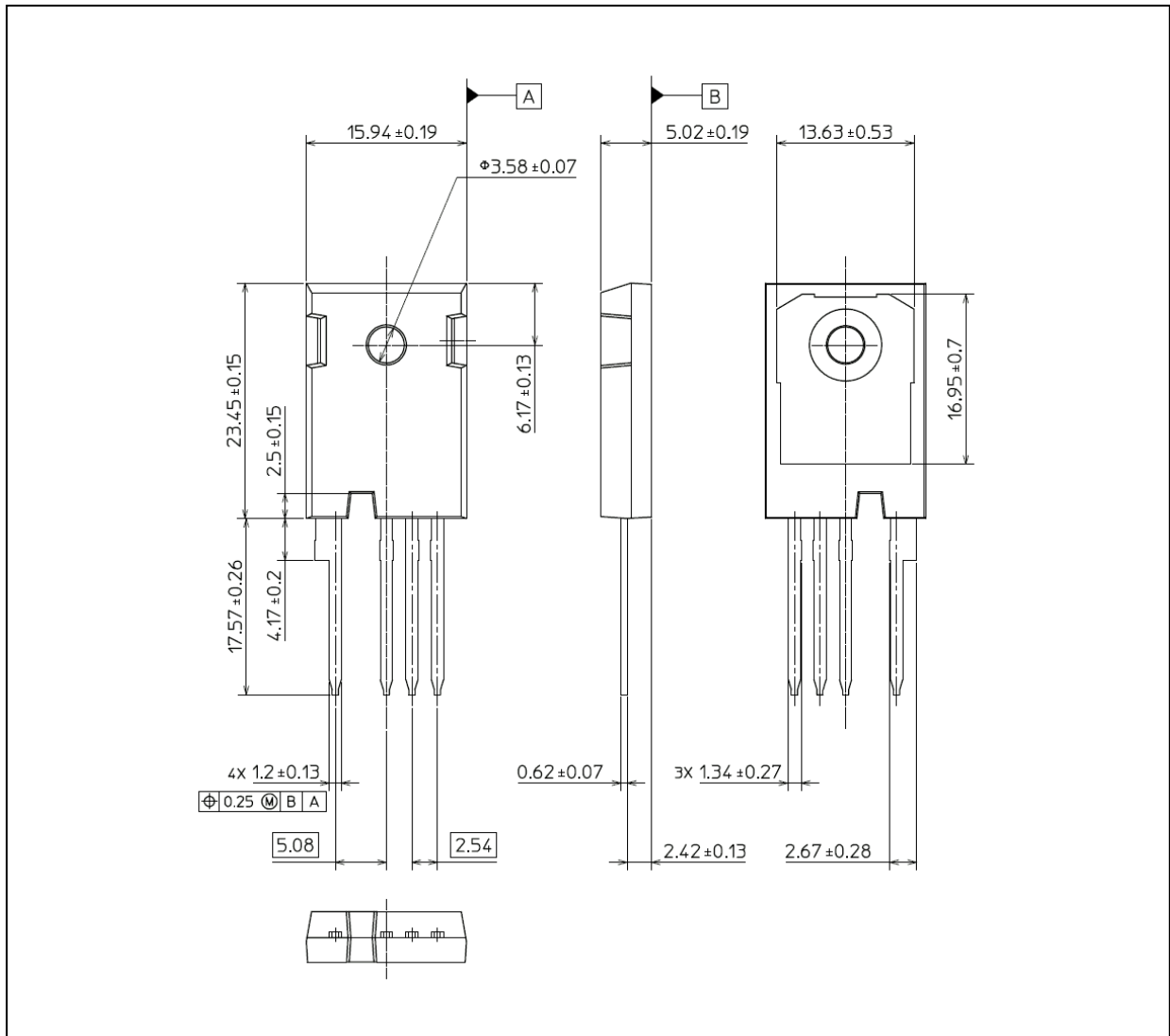


**Fig. 8.19  $P_D - T_c$  (Guaranteed Maximum)**
